

ORDINANCE NO. 101

CITY OF LACEY

AN ORDINANCE TO FIX THE AMOUNT OF THE AD VALOREM TAX LEVIES NECESSARY TO RAISE THE AMOUNT OF THE ESTIMATED EXPENDITURES, LESS THE ESTIMATED REVENUES FROM SOURCES OTHER THAN AD VALOREM TAXATION, FOR THE GENERAL FUND AND FOR THE PAYMENT OF PRINCIPAL AND INTEREST UPON THE GENERAL BONDED INDEBTEDNESS OF THE CITY OF LACEY FOR THE FISCAL YEAR 1969; TO LEVY THE ANNUAL AD VALOREM TAXES OF THE CITY OF LACEY FOR THE FISCAL YEAR 1969 AND APPROPRIATING SAME TO CERTAIN FUNDS FOR CERTAIN PURPOSES.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LACEY:

Section 1. That the annual amount of ad valorem tax levies of the City of Lacey for the fiscal year 1969 necessary to raise the amount of estimated expenditures, be and the same are hereby levied upon real and personal property subject to taxation in said City in all assessment districts thereof and upon each dollar of taxable value as follows, to-wit:

In all assessment districts for the payment of:

\* \$60,672.00 (4 mills) to be paid to Fire District No. 3

Section 2. That said taxes herein provided for are levied for the purpose of raising revenue sufficient to pay the principal and interest upon the general bonded indebtedness, if any, of the City of Lacey, for a portion of the General Fund, and for the operation of the different departments of the municipal government of the City of Lacey for the fiscal year beginning January 1, 1969, and ending December 31, 1969; and are hereby levied upon all the real and personal property as shown by the


assessment in the County of Thurston as finally fixed by the County and State Boards of Equalization, and as extended upon the books of the County Assessor showing the property within said City subject to taxation for municipal purposes and upon the amount of real and personal property as certified by the County Assessor, which certificate was heretofore received by the City of Lacey, all pursuant to and under and by virtue of the laws of the State of Washington.

Section 3. That the taxes collected from the levies hereby fixed and made, together with the estimated revenues from sources other than ad valorem taxation which constitute the appropriations of the City of Lacey for the fiscal year 1969, are hereby appropriated as itemized and classified in the Annual Budget for the fiscal year 1969 as adopted by Ordinance No. 100.


