

ORDINANCE 1091

CITY OF LACEY

AN ORDINANCE OF THE CITY OF LACEY, WASHINGTON, RELATING TO THE COMPENSATION OF MEMBERS OF THE CITY COUNCIL AND AMENDING SECTION 2.10.010 OF THE LACEY MUNICIPAL CODE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LACEY, WASHINGTON, as follows:

Section 1. Section 2.10.010 of the Lacey Municipal Code is hereby amended to read as follows:

2.10.010 Salary. The compensation of each city council member shall be the sum of ~~\$450.00~~ \$701.00 per calendar month. Provided, however, the monthly compensation for the calendar year 1999 shall be \$725.00 and the monthly compensation for each calendar year subsequent to 1985 1999 shall be an amount which results from adding the sum of \$25.00 an amount equal to the percentage increase in the All Urban Consumer Price Index for the Seattle Region for the prior calendar year to the monthly salary applicable to the prior calendar year. Said compensation shall be so determined and paid by the city without further action by the city council.

Section 2. No member of the city council serving on the date of passage of this ordinance shall receive the increase in compensation for the calendar year 1999 or any subsequent calendar year prior to the election of such council member to a new term upon the city council.

Section 3. The summary of this Ordinance, which is attached hereto, is approved for publication.

SUMMARY FOR PUBLICATION

ORDINANCE 1091

CITY OF LACEY

The City Council of the City of Lacey, Washington, passed on November 5, 1998, Ordinance No. 1091 entitled "AN ORDINANCE OF THE CITY OF LACEY, WASHINGTON, RELATING TO THE COMPENSATION OF MEMBERS OF THE CITY COUNCIL AND AMENDING SECTION 2.10.010 OF THE LACEY MUNICIPAL CODE."

The main points of the ordinance are described as follows:

- 1) The Ordinance modifies the manner of setting the compensation of members of the city council. Prior to passage of this ordinance, the compensation increased by an amount equal to the cost of living increase. However, this ordinance modifies that procedure to call for a set \$25 increase each year so that the amount of the compensation for the future will always be known.
- 2) Section 2 of the ordinance prohibits any existing council members from receiving the increases in compensation during the current term of such a council member.
