

ORDINANCE #1122

CITY OF LACEY

AN ORDINANCE INCREASING THE BASIC SEWER SERVICE CHARGE IN ORDER TO ACCOMMODATE THE INCREASE IN THE MONTHLY CHARGE FOR TREATMENT BY THE LOTT SYSTEM, AMENDING SECTION 13.16.060 OF THE LACEY MUNICIPAL CODE AND APPROVING A SUMMARY FOR PUBLICATION.

WHEREAS, the City Council has previously set the basic sewer service charge for Lacey at a rate which included a charge by the LOTT System of \$21.00 per equivalent residential unit per month, however, in setting such rate, has been aware of a pending recommendation from the LOTT Advisory Committee that the LOTT component of the Lacey Sewer Service Charge should be increased to \$25.50 per equivalent residential unit per month, and

WHEREAS, such recommendation has now been formally made to the City and after public hearing, the Council is in agreement with such recommendation,

NOW, THEREFORE,

BE IT ORDAINED by the City Council of the City of Lacey, Washington at follows:

Section 1. Section 13.16.060 of the Lacey Municipal Code is hereby amended to read as follows:

13.16.060 Basic service charge--Designated. The "basic sewer service charge" of Lacey shall be ~~\$33.30~~ \$37.80 per month per equivalent residential unit for all utility billings rendered on or after ~~April 1, 1999~~ December 31, 1999 and prior to April 1, 2000; ~~\$33.90~~ \$38.40 per month per equivalent residential unit for all utility billings rendered on or after April 1, 2000 and prior to April 1, 2001; and ~~\$34.50~~ \$39.00 per month per equivalent residential unit for all utility billings rendered on or after April 1, 2001 and ~~prior to April 1, 2002.~~

Section 2. This ordinance shall take effect on December 31, 1999.

Section 3. The summary attached hereto is hereby approved for publication.

SUMMARY FOR PUBLICATION

ORDINANCE #1122

CITY OF LACEY

The City Council of the City of Lacey, Washington, passed on December 16, 1999, Ordinance No. 1122 entitled "AN ORDINANCE INCREASING THE BASIC SEWER SERVICE CHARGE IN ORDER TO ACCOMMODATE THE INCREASE IN THE MONTHLY CHARGE FOR TREATMENT BY THE LOTT SYSTEM, AMENDING SECTION 13.16.060 OF THE LACEY MUNICIPAL CODE AND APPROVING A SUMMARY FOR PUBLICATION."

The main points of the ordinance are as follows:

1. The ordinance increases the City's basic sewer service charge by \$4.50 per equivalent residential unit per month in order to account for this same \$4.50 per month increase in the monthly sewer service charge rendered by the LOTT partnership to the City of Lacey. The modified rate follows the recommendation of the LOTT Advisory Committee which has been contemplated and discussed by the LOTT Partners and the public for a period in excess of one year.

2. In order to accommodate the increase, the existing basic sewer service charge rate set forth in section 13.16.060 of the Lacey Municipal Code is increased, in each instance, by the sum of \$4.50 per month.

3. The effective date of the ordinance is December 31, 1999.
