

ORDINANCE NO.

CITY OF LACEY

AN ORDINANCE AMENDING THE APPROPRIATION FOR THE CITY LIBRARY, PREVIOUSLY MADE BY BUDGET ORDINANCE NO. 100, PASSED NOVEMBER 7, 1968, SETTING FORTH ANTICIPATED REVENUES AND EXPENDITURES FOR THE LIBRARY, TRANSFERRING FUNDS FROM THE NON-DEPARTMENTAL FUND TO THE LIBRARY FUND, AND DECLARING AN EFFECTIVE DATE.

WHEREAS, there exists an emergency under the authority of Chapter 95, Section 12, Laws of 1969, ex. sess., in that it is necessary for the immediate preservation of the public health, safety and welfare of the City of Lacey, that additional funds be provided to Lacey Public Library to provide \$4,409.00 for building maintenance and operation, in accordance with the schedule of maintenance and operation expenses set out herein on Exhibit "A", by this reference incorporated herein, and

WHEREAS, there was previously appropriated in the Budget Ordinance No. 100, passed November 7, 1968, for library services, \$27,200.00, and \$27,151.00 of said sum is needed and has been contracted to the Timberland Regional Library for providing library services for the year 1969, leaving a need for the additional sum of \$4,409.00 for building maintenance and operation, and that an emergency exists, and without said additional appropriation, it will be impossible to maintain said public library service in the City of Lacey for the balance of 1969, NOW THEREFORE,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LACEY:

Section 1. That the annual budget for the City of Lacey, appropriated by Ordinance No. 100, passed November 7, 1968, is amended by transferring \$4,409.00 from the Non-Departmental

fund of the General Government to the Library Fund, making a total appropriation for the Library Fund of the City of Lacey for the year, 1969, in the amount of \$31,609.00.

Section 2. This Ordinance shall take effect five days after its passage and publication.


