ORDINANCE NO. 1177

CITY OF LACEY

AN ORDINANCE ADDING A YOUTH REPRESENTATIVE TO CERTAIN COUNCIL ADVISORY BOARDS AND COMMISSIONS (HISTORICAL COMMISSION, BOARD OF PARK COMMISSIONERS, AND LIBRARY BOARD) AND AMENDING LACEY MUNICIPAL CODE SECTIONS 2.42.020, 2.44.020, AND 2.46.020.

WHEREAS, the City Council of the City of Lacey has determined that it is important to have youth representation and a youth perspective on the Historical Commission, Board of Park Commissioners, and the Library Board, now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LACEY, WASHINGTON, as follows:

Section 1. Section 2.42.020 of the Lacey Municipal Code is hereby amended to read as follows:

2.42.020 Membership--Terms.

A. The commission shall consist of seven <u>general</u> members <u>and one youth member</u> appointed by the mayor and confirmed by the city council. Terms <u>for general members</u> shall be for three years. <u>General Mm</u>embership on the commission shall be limited to two full terms.

The youth member shall be between the ages of 16 and 18(when appointed), enrolled as a Junior or Senior in the North Thurston School District; or enrolled in private school or homeschooled in Lacey or Lacey's Urban Growth Management Area, and be a resident of the city of Lacey or reside in Lacey's Urban Growth Management Area. The youth member shall be appointed to serve for a term of one year. The youth member shall be limited to one appointed term. Except as outlined in this paragraph, the youth member shall have the same rights and responsibilities of the general members.

- B. The commission members shall not receive any salary or other compensation for services rendered on the commission, but necessary expenses actually incurred and within the budget as set by the annual budget ordinance shall be paid.
- C. Vacancies occurring otherwise than through the expiration of terms shall be filled for the unexpired terms. Members may be removed, after public hearing, by the mayor with the approval of the city council, for inefficiency, neglect of duty or malfeasance in office. The members shall be selected without respect to political affiliations.
- D. The <u>General membership on the</u> commission shall always include at least two professionals who have experience in evaluating historic resources and are selected from among the disciplines of history, architecture, architectural history, historic preservation, planning, cultural anthropology, archaeology, cultural geography, or American studies. The

commission action that would otherwise be valid shall not be rendered invalid by the temporary vacancy of one or both of the professional positions unless the commission action is related to meeting certified local government (CLG) responsibilities cited in the certification agreement between the mayor of Lacey and the state historic preservation officer. Furthermore, exception to the residency requirement of <u>general</u> commission members may be granted by the mayor and city council in order to obtain representatives from these disciplines.

Section 2. Section 2.44.020 of the Lacey Municipal Code is hereby amended to read as follows:

2.44.020 Membership--Terms. The board shall consist of five general commissioners and one youth commissioner to be appointed by the mayor with the consent of the city council. At least four of the general commissioners shall be residents of the city of Lacey. The fifth general commissioner may either be a resident of the city of Lacey or reside in Lacey's Urban Growth Management Area. Except for the initial terms, general commissioners shall be appointed to serve for a term of three years. General Membership on the commission shall be limited to two appointed terms.

The youth commissioner shall be between the ages of 16 and 18(when appointed), enrolled as a Junior or Senior in the North Thurston School District; or enrolled in private school or homeschooled in Lacey or Lacey's Urban Growth Management Area, and be a resident of the city of Lacey or reside in Lacey's Urban Growth Management Area. The youth commissioner shall be appointed to serve for a term of one year. The youth commissioner shall be limited to one appointed term. Except as outlined in this paragraph, the youth commissioner shall have the same rights and responsibilities of the general commissioners.

Section 3. Section 2.46.020 of the Lacey Municipal Code is hereby amended to read as follows:

2.46.020 Membership--Terms. The board shall consist of five <u>general</u> members <u>and one youth</u> <u>member</u> to be appointed by the mayor with the consent of the city council. At least four <u>of the</u> <u>general</u> board members shall be residents of the city of Lacey. The fifth <u>general</u> board member may either be a resident of the city of Lacey or reside in Lacey's Urban Growth Management Area. The first <u>general</u> appointments to the board shall be for terms of one, two, three, four and five years, respectively, and at the expiration of the first year and annually thereafter, as each term expires, a new <u>general</u> board member shall be appointed by the mayor with the consent of the council to serve for a term of five years.

The youth member shall be between the ages of 16 and 18(when appointed), enrolled as a Junior or Senior in the North Thurston School District; or enrolled in private school or homeschooled in Lacey or Lacey's Urban Growth Management Area, and be a resident of the city of Lacey or reside in Lacey's Urban Growth Management Area. The youth member shall be appointed to serve for a term of one year. The youth member shall be limited to one appointed term. Except as outlined in this paragraph, the youth member shall have the same rights and responsibilities of the general members. Board members shall not receive any salary or other compensation for services on the board, but necessary expenses actually incurred and within the budget as set by the annual budget ordinance shall be paid.
