WHEREAS, the City Council, in 1997, adopted the City of Lacey Comprehensive Plan for Outdoor Recreation 1997 as part of Ordinance No. 1051 and has incorporated said plan into the Lacey Comprehensive Plan under LMC Section 16.03.015, and

WHEREAS, the City has reviewed the goals and objectives of such plan and the park and open space needs of the community both within the corporate boundaries of the City and within the City's Urban Growth Management area and, after considering comments by members of the public, developed a new updated version of said plan entitled City of Lacey Comprehensive Plan for Outdoor Recreation 2004, and

WHEREAS, said plan has been recommended by the City Parks and Recreation Board and the City's Planning Commission and the Council finds the adoption of said plan to be in the public interest; NOW, THEREFORE

BE IT ORDAINED by the City Council of the City of Lacey, Washington, as follows:

Section 1. That certain document entitled City of Lacey Comprehensive Plan for Outdoor Recreation 2004 is hereby adopted as the City of Lacey Comprehensive Plan for Outdoor Recreation referenced in LMC Section 16.03.015 as a portion of the Lacey Comprehensive Plan.

## CITY OF LACEY

The City Council of the City of Lacey, Washington, passed on April 8, 2004, Ordinance No. 1223, entitled "AN ORDINANCE OF THE CITY OF LACEY, WASHINGTON, ADOPTING THE CITY OF LACEY COMPREHENSIVE PLAN FOR OUTDOOR RECREATION-2004 AS PART OF THE LACEY COMPREHENSIVE PLAN IDENTIFIED IN SECTION 16.03.015 OF THE LACEY MUNICIPAL CODE AND APPROVING A SUMMARY FOR PUBLICATION."

The main points of the Ordinance are described as follows:

- 1. The City Council had previously adopted the City Comprehensive Plan for Outdoor Recreation in 1997.
