

ORDINANCE NO. 1298

CITY OF LACEY

AN ORDINANCE RELATING TO THE COMPENSATION OF MEMBERS OF THE CITY COUNCIL, THE MAYOR AND DEPUTY MAYOR, AMENDING SECTIONS 2.09.020 AND 2.10.010 OF THE LACEY MUNICIPAL CODE AND ADOPTING A SUMMARY FOR PUBLICATION.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LACEY, WASHINGTON, as follows:

Section 1. Section 2.09.020 of the Lacey Municipal Code is hereby amended to read as follows:

2.09.020 Mayor's compensation. The city council member who is occupying the position of mayor, in addition to the salary as a council member, shall be entitled to an additional amount of ~~\$100.00~~ \$225.00 per calendar month. The city council member who is occupying the position of deputy mayor, in addition to the salary as a council member, shall be entitled to an additional amount of ~~\$50.00~~ \$115.00 per calendar month.

Section 2. Section 2.10.010 of the Lacey Municipal Code is hereby amended to read as follows:

2.10.010 Salary. The compensation of each city council member ~~shall be the sum of \$701.00 per calendar month. Provided, however, the monthly compensation for the calendar year 1999 shall be \$725.00 and the monthly compensation for each calendar year subsequent to 1999 and including 2007 shall be an amount which results from adding the sum of \$25.00 to the monthly salary applicable to the prior calendar year. The monthly compensation for each calendar year subsequent to 2007 shall be an amount which results from adding the sum of \$50.00 to the monthly salary applicable to the prior calendar year.~~ Said compensation shall be so determined and paid by the city without further action by the city council.





SUMMARY FOR PUBLICATION

ORDINANCE 1298

CITY OF LACEY

The City Council of the City of Lacey, Washington, passed on November 15, 2007, Ordinance No. 1298, entitled "AN ORDINANCE RELATING TO THE COMPENSATION OF MEMBERS OF THE CITY COUNCIL, THE MAYOR AND DEPUTY MAYOR, AMENDING SECTIONS 2.09.020 AND 2.10.101 OF THE LACEY MUNICIPAL CODE AND ADOPTING A SUMMARY FOR PUBLICATION."

The main points of the Ordinance are described as follows:

1. Currently the Mayor receives compensation of \$100.00 more than Council Members who are not serving as Mayor. This Ordinance increases that difference to \$225.00 per month. Further, the Deputy Mayor currently receives \$50.00 per month more than other Council Members. This Ordinance increases that difference to \$115.00 per month.
2. Currently the compensation of Council Members is increased each year by the sum of \$25.00 per month. This Ordinance modifies that increase to the sum of \$50.00 per month for years subsequent to 2007.
3. The Ordinance adopts this Summary for Publication.
