

ORDINANCE NO. 1306

CITY OF LACEY

AN ORDINANCE RELATING TO THE INDUSTRIAL PRETREATMENT REQUIREMENTS AND REGULATIONS OF THE CITY, AMENDING SECTION 13.10.010 OF THE LACEY MUNICIPAL CODE AND APPROVING A SUMMARY FOR PUBLICATION.

WHEREAS, the City has previously adopted the LOTT Discharge and Industrial Pretreatment Regulations as revised in 2005 as the official rules and regulations of the City for discharges into the City's Wastewater System and such regulations were updated in 2007 and adopted by the City, and

WHEREAS, the LOTT Board has unanimously approved a further revision to such regulations which may result in a net savings for the system and the City Council wishes to approve such modifications,

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LACEY, WASHINGTON, as follows:

Section 1. Section 13.10.010 of the Lacey Municipal Code is hereby amended to read as follows:


13.10.010 LOTT Discharge and Industrial Pretreatment Regulations. That certain document titled "LOTT Discharge and Industrial Pretreatment Regulations," as revised in 2007 and modified in 2008, is hereby adopted as the official rules and regulations of the City of Lacey setting forth industrial pretreatment requirements and regulations of discharges into the City's wastewater system. For purposes of said regulations, the term ~~"participant"~~ "City" shall mean the City of Lacey.

Section 2. The Summary attached hereto is hereby approved for publication.



SUMMARY FOR PUBLICATION

ORDINANCE NO. 1306

CITY OF LACEY

The City Council of the City of Lacey, Washington, passed on APRIL 10, 2008, Ordinance No. 1306, entitled "AN ORDINANCE RELATING TO THE INDUSTRIAL PRETREATMENT REQUIREMENTS AND REGULATIONS OF THE CITY, AMENDING SECTION 13.10.010 OF THE LACEY MUNICIPAL CODE AND APPROVING A SUMMARY FOR PUBLICATION."

The main points of the Ordinance are described as follows:

1. The Board of Directors of the LOTT Alliance has approved a modification of the LOTT Discharge and Industrial Pretreatment Regulations as were last revised in 2007. The modifications relate to the possible allowance of BOD discharge to offset the amount of methanol utilized by the system. This Ordinance approves the modification.
2. The Ordinance approves this Summary for publication.
