

ORDINANCE NO. 1346

CITY OF LACEY

AN ORDINANCE RE-ADOPTING SECTIONS 16.06.372, 16.06.374, 16.06.671, 16.64.010 – 16.64.030, 16.64.050 – 16.64.080 AND 16.64.100 AS THE SAME WERE ADDED OR AMENDED BY ORDINANCE NO. 1326 RELATING TO TEMPORARY HOMELESS ENCAMPMENTS AND ADOPTING A SUMMARY BY PUBLICATION.

WHEREAS, Ordinance 1326 adopted certain amendments to Sections 16.06.372, 16.06.374, 16.06.671, 16.64.010 – 16.64.030, 16.64.050 – 16.64.080 and added a new section, 16.64.100, all relating to temporary homeless encampments, and

WHEREAS, Section 14 of said Ordinance 1326 provided that the ordinance would be in effect for one year subject to further action by the Council and said year has expired,

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LACEY, WASHINGTON, as follows:

Section 1: Sections 16.06.372, 16.06.374, 16.06.671, 16.64.010 – 16.64.030, 16.64.050 – 16.64.080 and 16.64.100 are hereby re-adopted as the same are set forth at length in Ordinance No. 1326 and now codified in the designated sections of the Lacey Municipal Code.

Section 2: The Summary attached hereto is hereby approved for publication.
