

ORDINANCE NO. 1409

CITY OF LACEY

AN ORDINANCE OF THE CITY OF LACEY, WASHINGTON, ADOPTING THE CITY OF LACEY 2030 TRANSPORTATION PLAN AS PART OF THE LACEY COMPREHENSIVE PLAN IDENTIFIED IN SECTION 16.03.015 OF THE LACEY MUNICIPAL CODE AND APPROVING A SUMMARY FOR PUBLICATION.

WHEREAS, the current transportation plan was originally adopted by the City Council as part of Ordinance 1098 and incorporated into the Lacey Comprehensive Plan under Lacey Municipal Code Section 16.03.015, and

WHEREAS, the proposed 2030 Transportation Plan has been available to the public for review since December 2011, and

WHEREAS, the Lacey Planning Commission has performed a comprehensive comparison between the current Transportation Plan and the proposed Plan, and

WHEREAS, the City Planning Commission considered the proposed Plan and held a public hearing on November 20, 2012, and

WHEREAS, the City Planning Commission unanimously endorsed the proposed Plan, and

WHEREAS, the Council finds the adoption of said Plan to be in the public interest;

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LACEY,


WASHINGTON, as follows:


Section 2. The Summary attached hereto is hereby approved for publication.

SUMMARY FOR PUBLICATION

ORDINANCE NO. 1409

CITY OF LACEY

The City Council of the City of Lacey, Washington, passed on January 10, 2013, Ordinance No. 1409, entitled "AN ORDINANCE OF THE CITY OF LACEY, WASHINGTON, ADOPTING THE CITY OF LACEY 2030 TRANSPORTATION PLAN AS PART OF THE LACEY COMPREHENSIVE PLAN IDENTIFIED IN SECTION 16.03.015 OF THE LACEY MUNICIPAL CODE AND APPROVING A SUMMARY FOR PUBLICATION."

The main points of the Ordinance are described as follows:

- 1. The Ordinance reflects the fact that the proposed City of Lacey 2030 Transportation Plan was considered extensively by the Planning Commission of the City including at public hearing. Based upon the recommendation of the Planning Commission, the Council found the Plan to be in the public interest and adopted the 2030 Transportation Plan as part of the City's Comprehensive Plan referenced in Section 16.03.015 of the Lacey Municipal Code.**
