

ORDINANCE NO. 1440

CITY OF LACEY

AN ORDINANCE RELATING TO PARKING, REPEALING CHAPTERS 10.14, 12.08 AND 12.10 OF THE LACEY MUNICIPAL CODE, ADDING NEW CHAPTERS 10.14 AND 12.08 TO SAID CODE AND APPROVING A SUMMARY FOR PUBLICATION.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LACEY, WASHINGTON, AS FOLLOWS:

Section 1. Chapter 10.14 of the Lacey Municipal Code is hereby repealed.

Section 2. Chapter 12.08 of the Lacey Municipal Code is hereby repealed.

Section 3. Chapter 12.10 of the Lacey Municipal Code is hereby repealed.

Section 4. There is hereby adopted a new Chapter 10.14 of the Lacey Municipal Code to read as follows:

**10.14.010 No-parking signs.**

The director of public works with the concurrence of the police chief is authorized to erect signs indicating no parking upon the improved or unimproved portion of any public street, highway, alley or right-of-way. When official signs prohibiting parking are erected upon such streets as authorized in this section, no person shall park a vehicle upon any such street in violation of the signs.

**10.14.020 Restricted parking for commercial and recreational vehicles.**

1. Commercial Vehicles – No person shall park any commercial vehicle, farm vehicle, or special mobile equipment upon the improved or unimproved portion of any street, alley or public right-of-way for more than four hours with the following exceptions:

- a. Such vehicles may be parked temporarily for the purpose of loading or unloading of the vehicle; and

b. Such vehicles under ten thousand pounds gross weight may be parked overnight at the residence of the person responsible for the vehicle.

2. Recreational Vehicles – No person shall park any recreational vehicle, motor home, mobile home, trailer, camper, vessel or boat upon the improved or unimproved portion of any street, alley or public right-of-way for more than twenty four hours.

**10.14.030 No parking on sidewalks, walkways or bike paths.**

It shall be unlawful for any person to stop or park a motor vehicle upon any sidewalk, walkway or bike path within the city. For purposes of this section, the terms sidewalk, walkway and bike path shall mean those areas set aside within the public right-of-way for use by pedestrians, bicycles or a combination thereof and shall include that portion of said area adjacent to privately owned driveways.

**10.14.040 Violation-Fine.**

The violation of any of the provisions of this chapter shall constitute a parking infraction, with a monetary penalty not exceeding \$250.00.

Section 5. There is hereby adopted a new Chapter 12.08 of the Lacey Municipal Code to read as follows:

**12.08.010 Classification of Streets**

The street and roadway classifications and designations as set forth in the Lacey Comprehensive Plan as the same have been or are in the future amended by specific action of the City Council, shall constitute the official classifications and designations of the streets and roadways of the City of Lacey.


Section 6.    SEVERABILITY. If any section, sentence, clause or phrase of this ordinance should be held to be invalid by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this ordinance.

Section 7.    CORRECTIONS. The City Clerk and the codifiers of this ordinance are authorized to make necessary corrections to this ordinance including, but not limited to, the correction of scrivener's/clerical errors, references, ordinance numbering, section/subsection numbers and any references thereto.


Section 8.    The Summary attached hereto is hereby approved for publication.
