

ORDINANCE NO. 1465

CITY OF LACEY

AN ORDINANCE OF THE CITY OF LACEY RELATED TO PARKING FOR PERSONS WITH DISABILITIES, REPEALING CHAPTER 10.04.021, ADDING NEW CHAPTER 10.14.035, AND AMENDING CHAPTER 10.14.040, ALL OF THE LACEY MUNICIPAL CODE AND APPROVING A SUMMARY FOR PUBLICATION.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LACEY, WASHINGTON, as follows:

Section 1. Chapter 10.04.021 of the Lacey Municipal Code is hereby repealed.

Section 2. There is hereby adopted a new Chapter 10.14.035 of the Lacey Municipal Code to read as follows:

10.14.035 Parking for persons with disabilities.

Chapter 46.19.050 of the Revised Code of Washington as the same currently exists or is hereafter amended is hereby adopted and by this reference made a part of this chapter as though fully set forth herein.

Section 3. Chapter 10.14.040 of the Lacey Municipal Code is hereby amended to read as follows:

10.14.040 Violation-Fine.

The violation of any of the provisions of this chapter shall constitute a parking infraction, with a monetary penalty not exceeding ~~\$250~~450.00.

Section 4. SEVERABILITY. If any section, sentence, clause or phrase of this ordinance should be held to be invalid by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this ordinance.



Section 6. The Summary Attached is hereby approved for publication.



The City Council of Lacey, Washington passed on March 26, 2015, Ordinance No. 1465, entitled "AN ORDINANCE OF THE CITY OF LACEY RELATED TO PARKING FOR PERSONS WITH DISABILITIES, REPEALING CHAPTER 10.04.021, ADDING NEW CHAPTER 10.14.035, AND AMENDING CHAPTER 10.14.040, ALL OF THE LACEY MUNICIPAL CODE AND APPROVING A SUMMARY FOR PUBLICATION."
