ORDINANCE No. 27

AN ORDINANCE relating to and regulating motor vehicles, traffic, travel and transportation and their incidents upon the public streets, bicycle paths, and other ways open to the public; prescribing the powers and duties of officers and others in relation thereto; defining offenses; and providing penalties.

THE CITY COUNCIL OF THE CITY OF LACEY DO ORDAIN AS FOLLOWS:

Section 1. The following statutes of the State of Washington as they now exist and as they may be hereafter amended are hereby adopted by reference.

Section 2. Unless another penalty is expressly provided by law, every person convicted of a violation of any provision of this ordinance shall be punished by a fine of not more than \$500 or imprisonment for not more than 6 months or by both such fine and imprisonment.
