ORDINANCE NO. 56  
CITY OF LACEY

AN ORDINANCE ANNEXING CERTAIN REAL PROPERTY TO THE CITY OF LACEY UNDER THE PROVISIONS OF THE LAWS OF 1945, CHAPTER 128 RCW. Sec 35.13.130, 35.13.140 and 35.13.150 AND COMPLYING WITH THE PROCEDURE THEREIN SET FORTH.

THE CITY COUNCIL OF THE CITY OF LACEY DO ORDAIN AS FOLLOWS:

Section 1. That there has been filed with the City Council a petition in writing, signed by the owners of more than seventy-five (75%) percent of the assessed value of the property, according to the assessed valuation of the real property described in the said petition; that the said petition sets forth a legal description of the said real property; that the said petition was accompanied by a plat or drawing outlining the boundaries of the property sought to be annexed.

Section 2. That Thursday, July 20, 1967, was set as a date for a public hearing on said petition; that notice of such hearing has been published in the Olympia News and the Daily Olympian, newspapers of general circulation in the City of Lacey, that notice of such hearing was also posted in three (3) public places within the territory proposed for annexation; that said notices specified the time and place of such hearing and invited interested persons to appear and voice approval or disapproval of the annexation; that the expense of publication and posting of said notices was borne by the signers of the petition.

Section 3. That the following described property, located in the County of Thurston, State of Washington, to wit:

"Part of Government Lot 2, Section 27 N, Range 18 West described as follows:

Commence intersection of south line gov't lot 2 and center line of Section 27, Township 18 North, Range 1 West W.M. thence north along said center line 169 feet, thence east parallel to south line Lot 2, 944.3 feet, thence south 15 feet to a point 154 feet north of south line of Lot 2, thence east parallel to said south line to government meander line of Long Lake, thence southeasterly along said meander line to the south line of said Lot 2, thence west along said south line to the point of beginning, together with shore lands adjacent to and abutting upon. Including any portion of county road, known as Carpenter Road, adjoining the Andrews tract on the west for the required contiguity with existing limits of Lacey.

be and the same is hereby annexed to the City of Lacey, effective the 3rd day of August, 1967.

Section 4. This ordinance shall take effect and be in force five (5) days after its passage, approval and publication.
