

ORDINANCE 561

CITY OF LACEY

AN ORDINANCE RELATING TO COST OF LIVING INCREASES FOR THE MAYOR AND COUNCIL MEMBERS OF THE CITY, REPEALING SECTION 2.10.010, AMENDING SECTION 2.09.020, AND ADDING A NEW SECTION, 2.10.010, TO THE LACEY MUNICIPAL CODE

WHEREAS, cost of living increases in the compensation of all city employees other than the mayor and city council members have been granted each year since the establishment, in 1977, of the compensation rate for the mayor and council members, and

WHEREAS, if said cost of living increases had been applied to the compensation of the city council members, the compensation of members other than the mayor in the calendar year 1980 would be \$210.00 per calendar month, and

WHEREAS, it is the desire and intent of the city council and by the passage of this ordinance it hereby directs that for each year subsequent to the calendar year 1980, that the compensation of the mayor and of each council member shall be increased over the compensation set by this ordinance for the calendar year 1980 by a percentage amount equal to that percentage of cost of living raise granted to all other employees of the City of Lacey without further action by the council and that the council member serving as mayor shall receive an additional amount of \$50.00 per calendar month while so serving; now, therefore

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LACEY, WASHINGTON, as follows:

Section 1. Section 2.10.010 of the Lacey Municipal Code is hereby repealed.

Section 2. Section 2.09.020 of the Lacey Municipal Code is hereby amended to read as follows:

"The city council member who is occupying the position of mayor, in addition to ~~his~~ the salary as a council member, shall be entitled while serving as mayor to an additional amount of ~~\$25.00~~ \$50.00 per calendar month."

Section 3. There is hereby added to the Lacey Municipal Code a new section, 2.10.010, to read as follows:

"The compensation of each city council member for the calendar year 1980 shall be the sum of \$210.00 per calendar month, payable on the last day of each calendar month. The compensation for the calendar year 1981 and each calendar year subsequent thereto shall be an amount which results from applying the cost of living increase or increases granted all other city employees when applied to the compensation set forth for the calendar year 1980, and said compensation shall be increased and paid by the city without further action by the city council."
