

ORDINANCE 633

CITY OF LACEY

AN ORDINANCE AMENDING THE AMOUNT OF THE AD VALOREM TAX LEVIES FOR THE FISCAL YEAR 1982 AS SET BY ORDINANCE NO. 628 AND AMENDING SAID ORDINANCE NO. 628 TO BECOME EFFECTIVE UPON PASSAGE

WHEREAS, Ordinance No. 628, passed by the City Council of the City of Lacey on the 24th day of September, 1981, was based upon a certificate of estimated assessed valuation received by the City from the County Assessor, and

WHEREAS, the final assessed valuation of real and personal property within the City of Lacey as certified by the County Assessor is more than set forth in the estimated certificate, NOW, THEREFORE,

Section 1. Section 1 of Ordinance No. 628 of the City of Lacey is hereby amended to read as follows:
