

ORDINANCE 798

CITY OF LACEY

AN ORDINANCE ESTABLISHING WATER RATES AND CONNECTION CHARGES WITHIN THOSE AREAS SERVED BY NEWLY PURCHASED WATER SYSTEMS

WHEREAS, the city is in the process of purchasing those certain systems owned by Beachcrest Water Company, Inc. and known as the Beachcrest, Meridian Acres, and The Seasons water systems, and

WHEREAS, it is necessary to set water rates for customers within the areas served by the newly acquired systems which rates will reflect the costs of purchasing said systems in addition to the costs of maintaining and operating said systems, and

WHEREAS, it is necessary to set a connection charge for those new customers within the areas served by said newly acquired systems which have not already paid a connection charge which will be in an amount equal to the connection charge made to other properties served by said systems, which connection charges are similar to various general facilities and connection charges levied upon other customers upon the City of Lacey water system; now, therefore

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LACEY, WASHINGTON, as follows:

Section 1. There is hereby added to the Lacey Municipal Code a new section to read as follows:

"Connection Charges Within Newly Acquired Water Systems.
Notwithstanding the provisions of Sections 13.52.010 and 13.52.015 relating to special connection charges for new water customers and notwithstanding the provisions of Section 13.32.005 relating to water general facilities charges, the connection charge for those

new connections made within the Beachcrest, Meridian Acres and The Seasons water systems for all customers who have not already paid said connection charges, shall be in the sum of \$1,000.00. Said connection charges shall be in lieu of all other connection charges levied by the city with the exception of those charges made for the construction of a standard new service connection by the city. Charges for the construction of a standard new service connection by the city shall be in accordance with Section 13.32.010 of the Lacey Municipal Code."

Section 2. There is hereby added to the Lacey Municipal Code a new section to read as follows:

"Water Rates for Customers of Newly Acquired Water Systems. Notwithstanding the provisions of Sections 13.32.020, 13.32.030 and 13.32.060 of the Lacey Municipal Code, the monthly service charges for customers within the Beachcrest, Meridian Acres and The Seasons water systems shall consist of a base rate of \$15.50 for the first 400 cubic feet of water consumed and an additional charge of \$0.80 for each 100 cubic feet of water consumed for each monthly billing period."
