ordinance 809

AN ORDINANCE AMENDING SECTIONS 12.08.020 AND 12.08.030 OF THE LACEY MUNICIPAL CODE AS THEY RELATE TO ARTERIAL STREETS

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LACEY, WASHINGTON, as follows:

Section 1. Section 12.08.020 of the Lacey Municipal Code is hereby amended to read as follows:

"The City shall have the following streets or planned streets designated as secondary or minor arterial streets:

- "A. Sleater-Kinney Road S.E. from Pacific Avenue S.E. to 21st Avenue S.E.;
- "B. Sleater-Kinney Road N.E. from 15th Avenue N.E. to 1020 feet south of Eighth 6th Avenue N.E.;
- "C. College Street N.E. from 15th Avenue N.E. to Martin Way;
- "D. Carpenter Road S.E., all portions within the city limits;
- "E. Golf Club Road S.E. from Pacific Avenue to Lacey Boulevard;
- "F. Ruddell Road S.E. from Lacey-Boulevard Pacific Avenue S.E. to the south city limits;
- "G. Lacey Boulevard from Golf Club Road to its eastern terminus at Pacific Avenue S.E.;
- "H. 14th Avenue S.E. from the west city limits to College Street S.E.;
- "I. 37th Street S.E. from the west city limits to College Street S.E.;
- "J. 6th Avenue S.E. from Sleater-Kinney Road S.E. to College Street S.E.;
- "K. 3rd Avenue S.E. from Golf Club Road S.E. to College Street S.E.;
- "L. Mullen Road from College Street S.E. to Ruddell-Road-S.E. the east city limits;
- "M:-Ruddell-Road-S:E:-from-Pacific-Avenue-to-Lacey-Boulevard;
- "M. Clearbrook Drive S.E. from Pacific Avenue to Lacey Boulevard;
- "N. Marvin Road N.E. from Interstate 5 to the north city limits;
- "O. All of Yelm Highway from the west city limits to the east city limits;



"P. A planned west/east arterial beginning at Carpenter Road N.E. on the western terminus and extending generally in an easterly direction north of Interstate 5 to its eastern terminus at Marvin Road N.E."

Section 2: Section 12.08.030 of the Lacey Municipal Code is hereby amended to read as follows:

"The City shall have the following streets designated as collector streets:

- "A. Eighth 6th Avenue N.E. from Sleater-Kinney Road N.E. to College Street N.E.;
- "B. 21st Avenue S.E. from Sleater-Kinney Road S.E. to Golf Club Road S.E.;
- "C. 22nd Avenue S.E. from Golf Club Road S.E. to Ruddell Road S.E.;
- "D. 25th Avenue S.E. from Ruddell Road S.E. to Lilac Street S.E.
- "E. Shady Lane Road S.E. from Lilac Street S.E. to Carpenter Road S.E.;
- "F. Lilac Street S.E. from Shady Lane S.E. to 25th Avenue S.E.;
- "G. Golf Club Road from 21st Avenue S.E. to 22nd Avenue S.E.;
 - "H. Franz Street S.E. from Pacific Avenue S.E. to Lacey Boulevard S.E.;
 - "I. 45th Avenue S.E. from College Street S.E. to Ruddell Road S.E."
