CITY OF LACEY

AN ORDINANCE AMENDING ORDINANCE 840 ANNEXING TERRITORY TO THE CITY OF LACEY CONSISTING OF TWO LOTS ON PACIFIC AVENUE AT THE EASTERLY BOUNDARY OF THE CITY WHICH AMENDMENT IS FOR THE SOLE PURPOSE OF CORRECTING A TECHNICAL ERROR IN THE LEGAL DESCRIPTION ATTACHED TO SAID ORDINANCE 840

WHEREAS, on August 25, 1988, the city council passed Ordinance 840 annexing property consisting of two lots on Pacific Avenue at the easterly boundary of the city, which property was legally described upon Exhibit "A" which was attached to said ordinance and although Exhibit "A" contained a technical error in legal description requiring correction by this amendatory ordinance, said technical error was not such a departure from the true property considered to raise any legal objections with proper notice or public hearing processes; now, therefore

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LACEY, WASHINGTON, that Ordinance 840 of the City of Lacey, passed on August 25, 1988, is hereby amended by substituting that certain document attached hereto and designated as "Exhibit 'A'--Amended" for that certain document attached to Ordinance 840 which was designated as Exhibit "A."

EXHIBIT "A"--ALENDED

ANNEXATION LEGAL DESCRIPTION

That part of Section 22, Township 18 North, Range 1 West W.M., described as follows: Beginning at the intersection of the east right-of-way line of Carpenter Road SE and the north right-of-way line of Pacific Avenue SE as it existed on September 25, 1980; thence north easterly 470 feet more or less to a point which is the intersection of the east property line of North Thurston School District and the north right-of-way line of Pacific Avenue SE and the true Point of Beginning of this description; thence N14 46'31"W 139 93 feet more or less; thence N75 07'29" E, 163.0 feet; thence S19 55'31"E, 177.73 feet to the south right-of-way line of Pacific Avenue as it existed on September 25, 1980; thence southwesterly along said right-of-way line an arc distance of 156.31 feet more or less; thence N14 46'31"E, 60.00 feet more or less to the true Point of Beginning and the end of this description.
