## ORDINANCE 862

AN ORDINANCE AMENDING SECTIONS 12.08.010, 12.08.020 AND 12.08.030 OF THE LACEY MUNICIPAL CODE AS THEY RELATE TO THE CLASSIFICATION OF STREETS

BE IT ORDAINED BY THE CITY COUNTY OF THE CITY OF LACEY, WASHINGTON, as follows:

<u>Section 1:</u> Section 12.08.010 of the Lacey Municipal Code is hereby amended to read as follows:

"The City shall have the following streets designated as major or principal arterial streets:

- "A. Sleater Kinney Road SE from Interstate 5 to Pacific Avenue;
- "B. College Street SE from Martin Way to the south city limits;
- "C. Martin Way from College Street SE to the east city limits;
- "D. All of Pacific Avenue from the west city limits to the east city limits:
- "E. Marvin Road NE from Interstate 5 to the north city limits;
- "F. All of Yelm Highway from the west city limits to the east city limits."

Section 2: Section 12.08.020 of the Lacey Municipal Code is hereby amended to read as follows:

"The City shall have the following streets or planned streets designated as secondary or minor arterial streets:

- "A. Sleater Kinney Road SE from Pacific Avenue SE to 21st Avenue SE;
- "B. Sleater Kinney Road NE from 15th Avenue NE to 1020 feet south of 6th Avenue NE;
- "C. College Street NE from 15th Avenue NE to Martin Way;
- "D. Carpenter Road SE, all portions within the city limits;
- "E. Golf Club Road SE from Pacific Avenue to Lacey Boulevard;
- "F. Ruddell Road SE from Pacific Avenue SE to the south city limits;
- "G. Lacey Boulevard from Golf Club Road to its eastern terminus at Pacific Avenue SE;
- "H. 14th Avenue SE from the west city limits to College Street SE;
- "I. 37th Street SE from the west city limits to College Street SE;
- "J. 6th Avenue SE from Sleater Kinney Road SE to College Street SE;

- "K. 3rd Avenue SE from Golf Club Road SE to College Street SE;
- "L. Mullen Road from College Street SE to the east city limits;
- "M. Clearbrook Drive SE from Pacific Avenue to Lacey Boulevard;
- "N.--Marvin-Road-NE-from-Interstate-5-to-the-north-eity-limits;
- "O---All-of-Yelm-Highway-from-the-west-city-limits-to-the-east-city
- "P. "N. A planned west/east arterial beginning at Carpenter Road NE on the western terminus and extending generally in an easterly direction north of Interstate 5 to its eastern terminus at Marvin Road NE;
- "O. Rainier Road from Yelm Highway to the south city limits;
- "P. Hogum Bay Road from Marvin Road to the north city limits."
- Section 3: Section 12.08.030 of the Lacey Municipal Code is hereby amended to read as follows:
  - "The City shall have the following streets designated as collector streets:
  - "A. 6th Avenue NE from Sleater Kinney Road NE to College Street NE;
  - "B. 21st Avenue SE from Sleater Kinney Road SE to Golf Club Road SE;
  - "C. 22nd Avenue SE from Golf Club Road SE to Ruddell Road SE;
  - "D. 25th Avenue SE from Ruddell Road SE to Lilac Street SE;
  - "E. Shady Lane Road SE from Lilac Street SE to Carpenter Road SE;
  - "F. Lilac Street SE from Shady Lane SE to 25th Avenue SE;
  - "G. Golf Club Road from 21st Avenue SE to 22nd Avenue SE;
  - "H. Franz Street SE from Pacific Avenue SE to Lacey Boulevard SE;
  - "I. 45th Avenue SE from College Street SE to Ruddell Road SE;
  - "J. 31st Avenue NE from Hogum Bay Road to east city limits;
  - "K. 54th Avenue SE from Ruddell Road SE to east city limits;
  - "L. 7th Avenue SE from Sleater Kinney Road SE to Golf Club Road SE;
  - "M. Golf Club Road SE from 7th Avenue SE to Lacey Boulevard SE;
  - "N. Golf Club Road SE from 6th Avenue SE to 7th Avenue SE;
  - "O. 39th Avenue SE from College Street SE to Stikes Drive SE;
