ORDINANCE 880

#### CITY OF LACEY

AN ORDINANCE AUTHORIZING AND DIRECTING THE CITY ATTORNEY FOR THE CITY OF LACEY TO PURCHASE AND/OR INSTITUTE AND PROSECUTE TO DETERMINATION IN THE PROPER COURT, OR COURTS, AN ACTION OR ACTIONS IN THE NAME OF THE CITY OF LACEY UNDER THE RIGHT OF EMINENT DOMAIN FOR THE CONDEMNATION AND ACQUISITION OF EASEMENTS OVER CERTAIN LANDS AND PROPERTY FOR THE PURPOSE OF CONSTRUCTING SEWERAGE LINES AND APPURTENANCES; PROVIDING FOR THE PAYMENT FOR SAID EASEMENTS FROM THE CITY'S U.L.I.D. NO. 11 FUND OR SUCH OTHER FUND AS MAY BE DETERMINED, AND DECLARING A PUBLIC USE AND NECESSITY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LACEY, WASHINGTON, as follows:

Section 1. That the City Attorney is hereby authorized and directed to purchase and/or institute and prosecute to determination in the proper court, or courts, an action or actions in the name of the City of Lacey under the right of eminent domain for the condemnation and acquisition of easements over certain lands and property to be utilized for construction and maintenance of sewerage lines and appurtenances, situated in Thurston County, Washington, and legally described in Exhibit "A" attached hereto and by this reference made a part hereof. Said property is sought for sewerage system improvements and extensions, the same all being a part of the Utility Local Improvement District No. 11 project.

Section 2. That the acquisition of said lands and property and property rights for the purposes herein mentioned is for a public use and necessity.

Section 3. That payment for the lands and property and

property rights herein ordered to be taken or damaged shall be made from the City's Utility Local Improvements District No. 11 Fund or temporarily from such other funds as shall be necessary.

Section 4. That nothing in this ordinance shall be construed as a waiver by the City of Lacey of its right to decline to take and pay for said lands, property and property rights after the amount of damage has been ascertained and within the time allowed by law.
