

ORDINANCE NO. 936

CITY OF LACEY

AN ORDINANCE AMENDING ORDINANCE NO. 928 OF THE CITY OF LACEY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LACEY, WASHINGTON, that Ordinance No. 928 of the City of Lacey, which Ordinance was titled:

"AN ORDINANCE AUTHORIZING AND DIRECTING THE CITY ATTORNEY FOR THE CITY OF LACEY TO PURCHASE AND/OR INSTITUTE AND PROSECUTE TO DETERMINATION IN THE PROPER COURT, OR COURTS, AN ACTION OR ACTIONS IN THE NAME OF THE CITY OF LACEY UNDER THE RIGHT OF EMINENT DOMAIN FOR THE CONDEMNATION AND ACQUISITION OF PROPERTY FOR THE PURPOSE OF CONSTRUCTING ROADWAYS, SIDEWALKS, BIKE LANES AND OTHER STREET IMPROVEMENTS, NECESSARY STORM WATER DRAINAGE FACILITIES, SEWERAGE LINES AND APPURTANCES AND THE PLACEMENT OF OTHER UTILITIES; PROVIDING FOR THE PAYMENT FOR SAID PROPERTY FROM THE CITY'S L.I.D. NO. 13 FUND OR SUCH OTHER FUND AS MAY BE DETERMINED, AND DECLARING A PUBLIC USE AND NECESSITY"

is hereby amended by amending that certain legal description of Parcels 25, 27 and 28 contained on Exhibit "A" to said Ordinance to read as follows:

PARCELS 25, 27 & 28:

THAT PORTION OF LOT 2 OF SHORT SUBDIVISION NO. SS-1609, AS RECORDED UNDER FILE NO. 1131347, RECORDS OF THE THURSTON COUNTY AUDITOR; LOCATED IN THE NORTHWEST QUARTER OF SECTION 33, TOWNSHIP 18 NORTH, RANGE 1 WEST, W.M., DESCRIBED AS FOLLOWS:

BEGINNING AT THE SOUTHWEST CORNER OF SAID LOT 2; THENCE ALONG THE SOUTH LINE OF SAID LOT 2 SOUTH 88°00'46" EAST, 34.00 FEET; THENCE NORTH 43°11'46" WEST, 33.26 FEET TO THE EAST LINE OF THE WEST 10.00 FEET OF SAID LOT 2; THENCE ALONG SAID EAST LINE NORTH 01°37'15" EAST, 226.00 FEET TO THE NORTH LINE OF SAID LOT 2; THENCE ALONG SAID NORTH LINE NORTH 88°00'46" WEST, 10.00 FEET TO THE WEST LINE OF SAID LOT 2; THENCE ALONG SAID WEST LINE SOUTH 01°37'15" WEST, 250.00 FEET TO THE POINT OF BEGINNING, AND

THE WEST 10 FEET OF LOTS 3 AND 4 OF SAID SHORT SUBDIVISION.

CONTAINING ~~2787~~ 6600 SQUARE FEET, MORE OR LESS.

SITUATE IN THE CITY OF LACEY, THURSTON COUNTY, STATE OF WASHINGTON.

SAID ORDINANCE NO. 928 IS FURTHER AMENDED by adding to said Exhibit the following Parcel description:

"PARCEL 57

THE WEST 13.00 FEET OF THE EAST 33.00 FEET OF THE NORTH HALF OF THE NORTHEAST QUARTER OF THE SOUTHEAST QUARTER OF SECTION 29, TOWNSHIP 18 NORTH, RANGE 1 WEST, W.M.,

EXCEPT THEREFROM THE NORTH 350.00 FEET,

ALSO EXCEPT THEREFROM THE SOUTH 150.00 FEET.

CONTAINING 2075 SQUARE FEET, MORE OR LESS.

SITUATE IN THE CITY OF LACEY, THURSTON COUNTY, STATE OF WASHINGTON."
