WHEREAS, the City of Lacey has heretofore adopted a six year comprehensive street program and has revised said program annually, and

WHEREAS, the Public Works Director and the Transportation and Utilities Committee of the City of Lacey have studied the city streets of Lacey and have presented a proposed revised and extended six year comprehensive street program and a public hearing has been held on said proposal on the 14th day of August, 1975, and

WHEREAS, it is in the best interests of the City of Lacey that said proposed program as presented and as attached to this resolution be adopted as the six year comprehensive street program of the City of Lacey, NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LACEY that the revised and updated Six Year Comprehensive Street Program attached to this resolution and made a part hereof, be adopted as the Six Year Comprehensive Street Program of the City of Lacey.

BE IT FURTHER RESOLVED that a copy of said revised Six Year Comprehensive Street Program, together with a copy of this resolution, be filed with the Director of Highways of the State of Washington.
