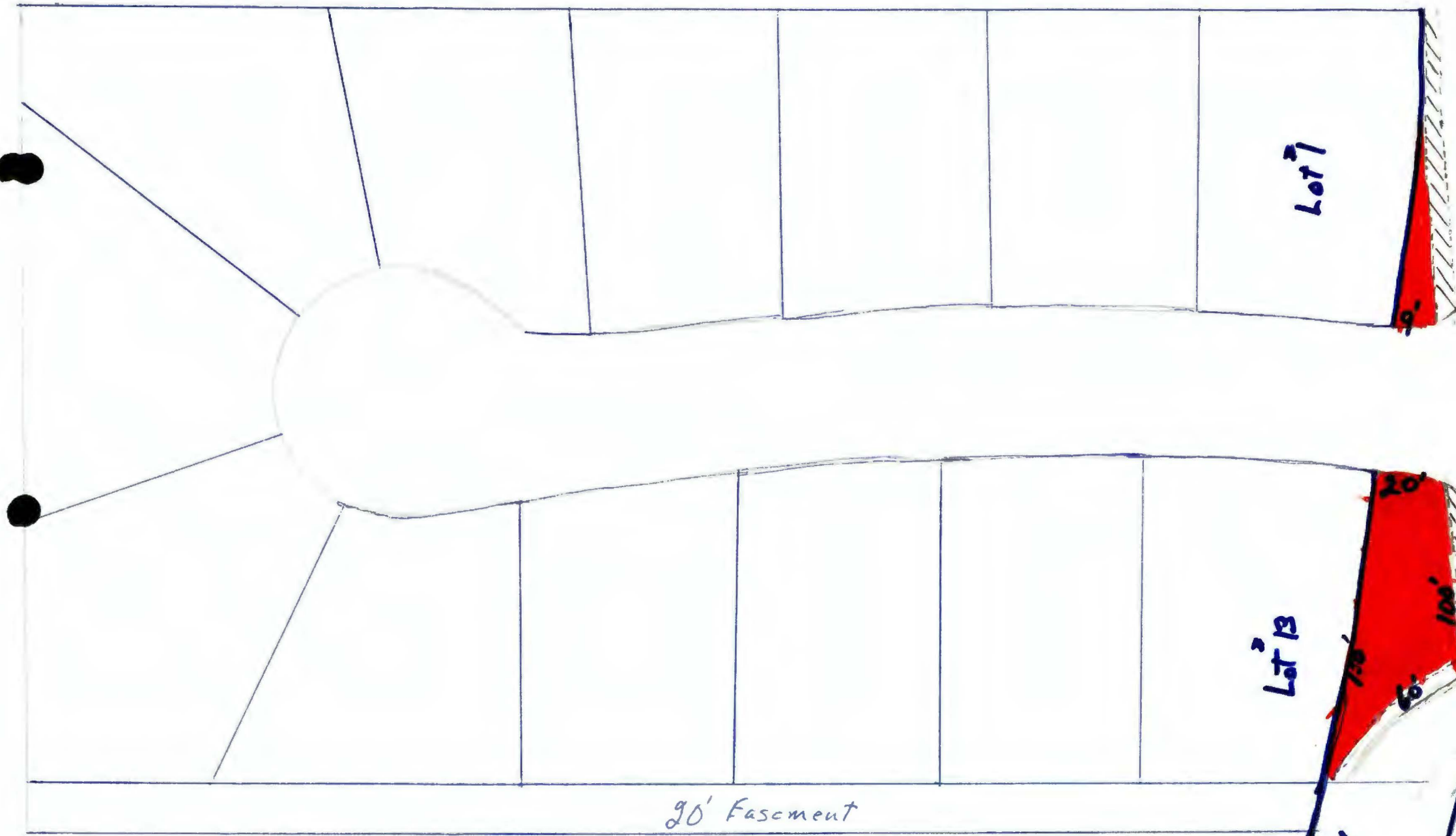

Description of property to be vacated.

Your petitioner is the developer of a small subdivision located at 32nd. Ct. and Ruddell Road, known as MAPLEGROVE. This subdivision consists of 13 lots which are located on the West side of Ruddell Road.

The property that your petitioner seeks to have vacated is that portion of Ruddell Road that lies East of the property line of lots # 1 and 13 of Maplegrove, and West of the right of way for Ruddell Road, and between 32nd Ct. S.W. on the North and Ruddell Loop Road on the South. The area in question is trapezium in shape. Approximate measurements, 20'x100'x60'x130'.

A diagram of the area in question is attached to further describe the property the petitioner is seeking to vacate.
