WHEREAS, the parties hereto have entered into that certain "Intergovernmental Contract for Wastewater Facilities Management" in November, 1976, and

WHEREAS, the LOTT Complex Facility Plan referred to in said Agreement is in need of updating and expansion, and

WHEREAS, the CITY OF LACEY has consented to become the lead agency for hiring a consultant to perform said services; now, therefore

IT IS HEREBY agreed between the parties as follows:

- 1. The CITY OF LACEY shall be the lead agency and shall advertise for, retain and supervise a sanitary engineering consulting firm hired for the purpose of updating the LOTT Complex Facility Plan within the LOTT Study Area and providing a comprehensive sewerage plan for the LOTT area in accordance with Federal and State Standards.
- 2. That the services called for in Paragraph 1 hereof shall be considered to be "Future Joint Facilities" within the definition of Section 2(f) of the "Intergovenmental Contract for Wastewater Facilities

 Management," and the staff costs incurred by the CITY OF LACEY and the consultant fee shall be considered "Joint Facilities Costs" within the definition of Section 2(i) of said contract.

3. The CITY OF LACEY shall, prior to entering into a final consultant agreement for said services, submit the same to the Technical Sub-Committee and to the Sewerage Facilities Advisory Committee for review and recommendation.

4. This Agreement shall not in any manner be construed to modify or amend that certain "Intergovernmental Contract for Wastewater Facilities Management," but shall only constitute an agreement made pursuant to that Contract.
