A RESOLUTION OFFICIALLY ADOPTING THE CITY'S URBAN BEAUTIFICATION PLAN INCLUDING AN ADDENDUM TO SUCH PLAN CALLING FOR THE EXTENSION OF THE STREET TREE PROGRAM AND OPTIONAL URBAN BEAUTIFICATION ELEMENTS TO ALL ARTERIAL AND COLLECTOR STREETS WITHIN THE CITY.

WHEREAS, in 1985, the city completed an Urban
Beautification Plan for the city's core area, which plan has been
utilized in the review of projects and improvements within such
area; and

WHEREAS, an addendum to such plan has been prepared extending the street tree program and the optional Urban Beautification elements of such plan to all arterial and collector streets now existing within the city or which may exist within city boundaries in the future; and

WHEREAS, it would be beneficial for the future of the city and it's residents that the Urban Beautification Plan together with its addendum, be officially adopted by the city; now therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LACEY, WASHINGTON, that that certain plan and program entitled "1985 Urban Beautification Plan" together with that certain addendum entitled "Street Tree Program for Arterial and Collector Street Addendum to

Urban Beautification Plan" are hereby adopted as the Urban Beautification Plan for the City of Lacey.

STREET TREE PROGRAM FOR ARTERIAL AND COLLECTOR STREETS ADDENDUM TO URBAN BEAUTIFICATION PLAN

- 1. Program to be implemented on all streets designated as
 - a. Arterials
 - b. Collectors
- 2. Planting theme
 - a. North/south streets
 - (1) Ratio 3 street trees to 1 accent tree
 - (2) Species: Street tree (Pennsylvania Lenceolata) Marshall/Green Ash

Accent tree - Flowering Cherry (Prunus species) or Flowering Plum (Prunus species)

- b. East/west streets
 - (1) Ratio 3 street trees to 1 accent tree
 - Species: street tree American Sweetgum (Liquidamber Styraciliflua)

Accent tree - Downy Serviceberry or Flowering Plum (Prunus species)

- 3. Planting size -1-1/2" to 2" caliper, six inches above the base
- 4. Location Minimum of 3 to 5 feet behind the backside of the sidewalk on private property, unless it is necessary to plant on city right-of-way. Spacing of trees: 35' to 40' on center.
- 5. All developments required to plant street trees will also be required to maintain the trees for the life of the project, regardless of ownership.
- 6. Exceptions to the planting theme may be made by the Director of Public Works and the Director of Parks and Recreation. Exceptions include but not limited to, screening industrial areas; planting around historical sites; maintaining natural vegetation that better serves as street landscaping/beautification.
- 7. Incentive program For projects that do not come before site plan review, (i.e. construction of single family home, rezone, variance) offer an incentive of up to 50% or a maximum of \$25.00 for the purchase of one street/accenttree or \$75.00 for the purchase of two trees.
- 8. Mandatory/optional urban beautification elements It will be mandatory that plant materials be utilized as one element of ground cover, i.e., grass, shrubs, etc., in addition to surface covers such as bark, rock, etc. In addition, options for shrubs ground cover and street furniture identified in the 1985 plan will be extended to all arterial and collector streets.
