A RESOLUTION ADOPTING A REVISED FEE SCHEDULE FOR THE LICENSING OF ANIMALS

WHEREAS, Section 1.20.010 of the Lacey Municipal Code requires that certain fees, charges and penalties for failure to pay said fees and charges in a timely manner be established by resolution of the City Council; and

WHEREAS, by passage of Resolution 536, fees for all services within the city were established; and

WHEREAS, the Joint Animal Control Commission has recommended that the fees and penalties for the licensing of animals be modified and standardized between member jurisdictions and the Council finds said recommendation to be in order; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LACEY, WASHINGTON, that the document entitled Joint Animal Control License Fee List be adopted as the schedule of fees, charges and penalties for the licensing of animals within the City of Lacey.
