CITY OF LACEY

A RESOLUTION ADOPTING AN AMENDED LACEY FEE SCHEDULE

WHEREAS, pursuant to Section 1.20.010 of the Lacey Municipal Code, the Council passed Resolution 651 setting Joint Animal Control license fees and Resolution 658 adopting the balance of the Lacey Fee Schedule; and

WHEREAS, after further review and consideration, it has been determined that there should be a fee for the issuance of land clearing permits equal to \$25.00 for the first acre and \$10.00 for each additional acre, that the wording regarding the fee for subdivision and PRD extensions in the adopted Fee Schedule is conflicting and that the fee for kennel licenses and final short plats was inadvertently omitted; now, therefore

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LACEY, WASHINGTON, that the attached hereto designated as the Lacey Fee Schedule and the Joint Animal Control license fee list, are hereby adopted as the schedule of fees, charges, bonding requirements and penalties of the City of Lacey until further action of this Council pursuant to Section 1.20.010 of the Lacey Municipal Code or is

otherwise modified by the terms of particular ordinances
establishing such fees or charges.
